**Information pursuant to Article 13 DSGVO on data collection**

The data of the participant will be processed by the Lower Austrian Badminton Association, ZVR: 379068339, 3100 St. Pölten, Dr. Adolf-Schärf-Straße 25, c/o Sport. Zentrum. NÖ, as the person responsible for the purpose of fulfilling the contract on the basis of the selected offer or implementation of pre-contractual measures in accordance with Art. 6 para. 1 lit b DSGVO.

The legal basis for data processing is the participant's consent as data subject to data processing pursuant to Art. 6 Para. 1 lit. a DSGVO or the fulfilment of a contractual agreement/implementation of pre-contractual measures pursuant to Art. 6 Para. 1 lit. b DSGVO.

The disclosure of the participant's personal data to third parties is only intended in fulfilment of the contractual obligations, namely to the associations/persons offering/implementing the respective offer as well as to any sponsor. The disclosure of personal data to other third parties is not intended. If such data are passed on to third parties, appropriate agreements will be made with these (contract processors).

The participant's data will be stored by the responsible person in the event of a contractual agreement or pre-contractual measures having been entered into, for the duration of the service provision/pre-contractual measures and the subsequent legal obligation to store the data for 10 years (subsidy accounts in accordance with BSFG 2017) from the date of entry into force, in the event of no contractual agreement being entered into, or at the end of the implementation of the pre-contractual measures, for up to 3 months after entry into force.
